## EXEMPTION FOR PROFESSIONAL TRAVEL

*This document, drawn up by the employer, is sufficient to justify an employee's business trip, be it:*

- their usual journey between their home and their place of work or their journey between various places of work when the nature of the employee's duties so requires;*
- journeys of a professional nature that cannot be postponed, at the request of the employer.*

*Therefore, the employee does not have to carry the derogatory travel certificate in addition to the present document. However, self-employed workers must fill in the certificate of derogatory travel and tick the primary reason for travel.*

*Please specify all the places where the employee's activity is carried out, unless the very nature of the activity — which must be carefully filled in — cannot be specified in advance (for example, deliveries, on-call tasks, etc.).*

*The period of validity of this certificate is to be determined by the employer (it is therefore not necessary to renew it daily) and must take into account the logistics of the business (e.g. staff rotation) as well as holidays or rest periods.*
